

## **Lürzer's Grand Slam Personal Data Protection**

### **User accounts**

In order to enter the competition and/or to create an account the registration process must be completed by providing complete and accurate information as stated in the applicable forms. The user is also required to choose a password. The user is entirely responsible for maintaining the confidentiality of the password and account. Furthermore, they are entirely responsible for any and all activities that occur under said account. The user hereby agrees to notify Lürzer's Grand Slam immediately of any unauthorized use of their account or any other breach of security. Lürzer's Grand Slam will not be liable for someone else using the password or account.

### **Personal Data Protection**

The data controller of the collected data is Lürzer & Lürzer GmbH, Keinergasse 29/2, 1030, Wien, AUSTRIA (herein referred to as Lürzer's Grand Slam or data controller). Contact details: [support@luerzersgrandslam.com](mailto:support@luerzersgrandslam.com). The data subject is the applicant or other data subject that has given his consent to personal data mainly for the purpose of participating in the competition, commercial communication or other contractual or statutory reasons.

The applicant or other data subject acknowledges that Personal Data provided to the Lürzer's Grand Slam are processed by the Lürzer's Grand Slam as the data controller. Processing of the Personal Data is necessary under the Agreement, to which the affected person is a party, or necessary for pre-agreement relations with the affected person or necessary during negotiations on the change in the Agreement, which take place at the request of the affected person for the purpose of competition, including cross-border transfer of Personal Data in to the EU. The data explicitly provided by the user are necessary for the contractual purpose. Data regarding payment are both of contractual and statutory nature especially, but not exclusively, in relation to accounting and tax regulations. Other usage of data that is for the purpose of commercial communication is based on the consents of such usage by the data subject. Consent for commercial communication can be withdrawn at any time. This existence of the right to withdraw consent at any time, does not affect the lawfulness of processing based on consent before its withdrawal.

The applicant or other data subject as the affected party, whose Personal Data are processed by the controller, shall be entitled at any time to check and change provided Personal Data as well as cancel its registration after logging-in. Applicant or other data subject has the right to request from the data controller access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability.

Rights of the applicant or other data subject, as the affected person are also the right to request from the data controller to provide the following in generally intelligible form:

- 1.a) confirmation whether or not its Personal Data are processed,
- 1.b) information whether its Personal Data re processed in the information system,
- 1.c) information about the source, from which the data controller has obtained its Personal Data for processing,
- 1.d) list of Personal Data which are processed,
- 1.e) correction or destruction of its incorrect, incomplete or outdated Personal Data which are processed,
- 1.f) destruction of its Personal Data, whose purpose has ceased or in case of a violation of the Act on the Protection of Personal Data.

The applicant or other data subject can express its consent with the processing of its Personal Data during or after its registration for the purposes of marketing communications and sales support, especially for sending information about promotions and other activities of the Lürzer's Grand Slam. This consent can be withdrawn at any time.

The data controller shall process Personal Data for the purpose set out in these General Terms and Conditions and in accordance with the applicable regulation, mainly EU General Data Protection Regulation.

The applicant or other data subject grants consent to the processing of Personal Data and the consent may be revoked at any time in writing by the applicant by sending a notice to the [support@luerzersgrandslam.com](mailto:support@luerzersgrandslam.com) .

Lürzer's Grand Slam, after fulfilling the purpose of processing or upon request to revoke the consent, shall provide for an immediate destruction of Personal Data of the applicant except where statutory provision request otherwise, such as data preserved in relation to accounting. Lürzer's Grand Slam shall handle the request of the applicant or other data subject within 30 days of receipt. Lürzer's Grand Slam shall inform the affected person and Office for Personal Data Protection of any

restriction of the rights of affected person.

Processed Personal Data includes: name, e-mail address, permanent address or other delivery address, payment details, telephone number, password, user name as provided by the applicant. The period that data will be stored is 10 years form the last transaction or request by the data subject.

The recipient of the data is the Lürzer's Grand Slam. Data regarding online behaviour (cookies) may be also shared with Google Analytics, Google Tag Manager, FB Pixel, Hotjar, LinkedIn, Insight, Pinterest. Financial transaction are processed via Online Payments Group AG.

Automated decision-making is done via cookies that are send to the user to personalize the experience on the website. The website uses permanent and temporary cookies that can remember preferences of the user during one or multiple sessions. Data regarding online behaviour (cookies) may be also shared with Google Analytics, Google Tag Manager, FB Pixel, Hotjar, LinkedIn, Insight, Pinterest. The user can change the cookies setting in his browser or via special cookies stetting placed on the website. Lürzer's Grand Slam do not transfer data to third countries. The main server is based in Ireland with all required technical and technological security measures.

Lürzer's Grand Slam shall inform the applicant or other data subject of additional information regarding the handling of Personal Data in the event of a transfer of an undertaking or part thereof or sale of the Seller to another person. ### **Limitation of liability and Dispute**

Any Legal dispute shall be settled primarily by agreement in good faith; mainly by negotiation or

alternative dispute resolution. Any unresolved disputes in this manner, shall be brought before the International Chamber of Commerce Arbitration court in Paris (ICC Arbitration) unless the parties to the disputer agree otherwise.

### **Changes**

Lürzer's Grand Slam reserves the right, at its sole discretion, to change, modify, add or remove any portion of these Terms of use in whole or in part, at any time. Changes shall be effective when posted on Lürzer's Grand Slam website. Lürzer's Grand Slam may terminate, change, correct any errors or omissions in any portion, make any other changes relating to the materials and products, programs, services or prices (if any) posted on Lürzer's Grand Slam website or contained in Lürzer's Grand Slam Terms and Conditions, suspend or discontinue any aspect, including the availability of any features or products of or on the Site, at any time without notice.
